#### **Materials Handling & Outbound Shipments**

## **Advanced Material Handling**

- Receive & store shipment up to 30 days in warehouse
- Delivery of shipment from advanced warehouse to show site
- Priority unloading status
- Removing of empty containers from booth to storage area
- Returning of empty containers to booth upon show closing
- Reloading of shipment from booth to exhibitor arranged outbound courier

## **Conditions**

- All orders must be prepaid
- All orders must be received at least 2 days prior to exhibitor move in or be subject to a 25% late fee
- There will be a surcharge of \$150.00 as well as import/duty fees that Handy Special Events is charged for. Exhibitors are responsible for finding a broker and paying all associated fees before your materials cross the boarder.
- Please arrange shipments to arrive between 9:30 am-4:30 pm Monday-Friday
- Loose and uncrated shipments will not be received
- Return Bill of Lading and/or shipping labels must be included with materials received and properly completed. A \$150.00 service charge will be applied to any material handling request without the required information.
- A service charge will not be applied if the return labels are emailed 3 days prior to the show opening

# **Outbound Shipments**

- It is the sole responsibility of the Exhibitor to properly pack & seal all boxes & crates
- Shipping label must be attached to **EACH** piece of any outbound shipment and attach a **COMPLETED bill of lading** covering each outbound shipment
- All old shipping labels must be removed
- Exhibitors are responsible for arranging pick up of their materials with a courier company
- We require Bill of Ladings from all couriers used in outbound shipments including local couriers picking up on behalf of a different courier
